

Frequently Asked Questions for BCCL-ke- LAAL/BCCL- ki- LAADLI Batch 2019-21

1. I have appeared in my class 10th board examination in 2018 or before. Can I be eligible for this program?

ANS: NO, this program is only for the candidates who are appearing in their class 10th board examination in **2019**.

2. Can I apply for Group-I through BCCL-ke- LAAL/BCCL- ki- LAADLI programme?

ANS: NO, Group-I of this programme exclusively comes under purview of Central Coalfields Limited (CCL), Ranchi. However, candidates may apply for Group-II open for the all the candidates residing in Jharkhand. The selection will be as per the criteria of CCL followed by BCCL. The candidates willing to study at the Video Conference (VC) Centres of BCCL can apply for the program.

3. Is there any fee for applying for this programme?

ANS: NO there is no application fee for the form. However, the candidates have to download the application form from the BCCL website i.e. www.bcclweb.in. The duly filled in form is to be submitted to Area Personnel Manager's Office in the premises of General Manager Office nearest to the residence of the applicant. The offices of the area is mentioned in the Information Brochure. The forms must be submitted on or before the stipulated date as mentioned in the advertisement.

4. My family income (includes income of Mother and Father both) is more than 6 lakhs per annum can I apply for this programme?

ANS: Yes, such candidates can also apply for this programme. However, preference will be given to the candidates whose family income from all sources is less than 6 lakhs rupees at the time of preparation of the merit list.

5. I want to do medical preparation after my class 10th. Can I apply for this programme?

ANS: This programme solely aims to provide online coaching for the students aspiring to appear in all India engineering entrance test ie IIT-JEE and other related examination.

6. I am a HINDI MEDIUM student. Can I apply for this programme?

ANS: Yes, this programme aims to include students from all the medium of instruction.

7. Will I get any reimbursement against any expenses incurred to appear in the entrance test of this programme?

ANS: No, reimbursement against any expenses incurred to appear in the entrance test of this programme will not be given in any case.

8. Post selection in this programme will I get reimbursement of travel from the company to attend this programme?

ANS: No, reimbursement with respect to any travel to attend this programme be given in any circumstances. It may be noted that the students selected for this programme will have to bear all the travel expenses on their own to attend this programme.

9. When and how I will get to know about the date and time of the entrance test?

ANS: The date of ENTERANCE TEST will be notified on our website i.e. www.bcclweb.in. Candidates are requested to regularly check the website. The centre along with the name and roll number, dated and time will be notified on the website mentioned above.

10. After completing this coaching programme will I be eligible for any future employment in BCCL.
