**Sub: New Coal Distribution Policy – Amendment regarding increasing the annual cap of coal through State Nominated Agencies and amending phrase of small and medium sector-regarding.**

Dear Sir,

Copy of Office Memorandum no. 23011/90/2013-CPD dtd. 27.09.2016 issued by MoC on the subject has been forwarded vide this office letter no.CIL/S&M/47252/1068 dtd. 28.09.2016. It is further requested to give wide publicity to same and arrange for uploading it on the coal company website.

With the amendments in NCDP – 2007, SNAs can now distribute coal in their state to small, medium and other consumers whose requirement is less than 10000 tons per annum and are not having access to purchase coal or conclude Fuel Supply Agreement (FSA) for coal supply with coal companies.

State Government Authorities who have not nominated State Agency may be asked to nominate the same and SNAs may be requested to sign the FSA keeping in view the wide scope of distribution of coal by SNAs with the amendments in NCDP.
