Sub: BCCL Board decision regarding Reserve Price in various e-Auction scheme.

As per the decision taken by 353rd CIL Board, Subsidiary Board have been empowered to fix Reserve Price for e-Auction schemes for any source(s) depending upon the market condition and remove the upper cap of 20%/10% presently in vogue. As such, after detailed deliberation BCCL Board on its 340th meeting held on 23.03.2018, inter alia accorded its approval for following modifications:

Reserve Price for Spot & Special Spot e-Auction:


Reserve Price for all grades of Coking Coal would be 40% over the Notified Price for Non-Regulated Sector and Reserve Price for all grades of Non-Coking Coal would be 35% over the Notified Price for Non-Regulated Sector.

Reserve Price for Special Forward e-Auction:

Reserve Price for all grades of Coking Coal would be 10% over the Notified Price for Power Sector and Reserve Price for all grades of Non-Coking Coal would be 15% over the Notified Price for Power Sector.

Reserve Price for Exclusive e-Auction:

Reserve Price for ST-I, ST-II & Direct Feed grades of Coking Coal would be 10% over the Notified Price for Non-Regulated Sector and Reserve Price for all grades of Non-Coking Coal and W-I to W-IV grades of PCC and HVMC Coking Coal would be 25% over the Notified Price for Non-regulated Sector.
