**EXTENSION OF THIRD PARTY SAMPLING FACILITY FOR ALL CONSUMERS**

In terms of the CIL Board decision in its 353<sup>rd</sup> meeting held on 18<sup>th</sup> and 19<sup>th</sup> December'2017 conveyed vide Director (Marketing), CIL's letter no. CIL/DM/Secy/2733 dated 07.01.2018 (copy enclosed), facility of Third Party Sampling is being extended to the following categories of consumers:


- a. Spot, Special Spot and Exclusive e- Auction schemes towards coal secured in the events conducted on or after 01.01.2018.
- b. FSA consumers in Non- Power Sector including state nominated agencies, for dispatches against the MSQ for the month of January'2018 and beyond.

The above facility shall be applicable for all dispatches w.e.f. 11.01.2018 even against the coal secured in the auction events held before 01.01.2018/ booking of coal against the Monthly Scheduled Quantity for the months up to December'2017 under the FSAs.

Further, the consumers/ bidders willing to avail the facility of Third Party Sampling, will have to share the expenses and complete the requisite formalities. However, dispatches to the consumers/ bidders who are not willing to avail the sampling facility, shall be continued on declared-grade basis from 11.01.2018 subject to submission of an undertaking to the effect that they are not willing to avail the said facility.

The consumers/bidders desirous of availing the sampling facility may thus immediately express their willingness in writing and approach this office for completing the requisite formalities.

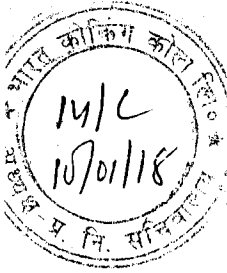

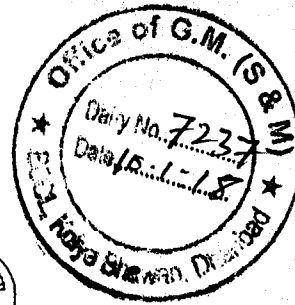

### Sub: Extension of third party sampling facility for all consumers.

This has reference to letter No.CIL/C4B/Third Party/13 dated 7.1.2018 of CIL vide which the Subsidiary Companies have been informed of the approval granted by CIL Board in its 353<sup>rd</sup> meeting held on 18<sup>th</sup> and 19<sup>th</sup> December,2017 for extending the third party sampling facility to the following categories of consumers:

- Spot, Special Spot and Exclusive e-Auction schemes towards coal secured in the events conducted on or after 1.1.2018.
- FSA consumers in Non-Power Sector including state nominated agencies, for despatches against the MSQ for the month of Jan'2018 and beyond.

With this decision, the facility for third party sampling is extended to all categories of consumers drawing coal from CIL.

It has now been decided further that the above said decision of 353<sup>rd</sup> CIL Board shall be applicable in respect of all despatches w.e.f 11.1.2018, even against the coal secured in the events of auctions held before 1.1.2018 / booking of coal against the MSQ for the months upto December,2017 under the FSAs.

As this facility is extended on optional basis for the willing consumers/bidders who are prepared to share the expenses and complete the requisite formalities, there shall be no force upon any of them to opt for third party sampling. However, despatches to such consumers / bidders be continued on declared grade basis from 11.1.2018, only after getting an undertaking to the effect that they are not willing to avail the option for third party sampling.


