ELIGIBILITY CRITERIA

2. The intending tenderer must have in its name experience of having successfully completed similar works during last 7(seven) years ending last day of the month previous to the one in which bid applications are invited(i.e. eligibility period) should be either of the following:

\*Three similar completed work each costing not less than amount equal to 40% of the estimated cost

OR

\*Two similar completed work each costing not less than amount equal to 50% of the estimated cost

OR

\*One similar completed work costing not less than amount equal to 80% of the estimated cost.

3. Similar work means : Drivage of Inclined shaft/Sinking of Strata bunker in stone in u/g mine.

4. Tenderers should also give the break up of activities alongwith the time schedule for completion of the job to be completed in three months.

5. Tender documents with full details & specification can be have from the office of the undersigned from 24.04.2009 to 29.04.2009 and sealed tender will be received upto 4.00 PM. on 30.04.2009 and sealed tender of technical bids will be opened on same day as on 30.04.2009 at 4.30PM. before the tenderer or their authorized representatives.
