NOTICE INVITING TENDER

Sealed tenders in two Parts (Part-I & II) are invited on percentage above/below basis from bonafide, experienced & resourceful Contractors for the following work -



Eligibility Criteria :

- The intending tenderers must have in its name experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which bid applications are invited i.e. eligibility period should be either of the following -
  - Three similar completed works each costing not less than the amount equal to 40% of the estimated cost  
Or
  - Two similar completed works each costing not less than the amount equal to 50% of the estimated cost  
Or
  - One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- Similar work means that the tenderer should have experience of civil construction/repairing works.
- Average annual financial turn over of civil works during last three years ending 31st March of the previous financial year should be atleast 30% of the estimated cost.
- Conditional tenders will not be accepted.
- Tenderers are to be submitted separately in two Sealed Covers containing (i) Techno Commercial bid and (ii) Price bid. The techno commercial bid should contain the proof of eligibility criteria as fixed above, the earnest money & details of TIN & PAN No. The Part-I will be opened on 11.05.2009 at 3.30 P.M. The Part-II containing the price bid will be opened by the committee only after acceptance of Part-I.
- The tender documents can be had from the Office of A.C.E., C.V.Area from 08.05.2009 to 09.05.2009 during office hours only on writing request and production of credential in support of the eligibility for issuance of tender documents.
- The experience given in the eligibility criteria should be in the name & style in which tender is filled. The experience of partner if any, in name or firm/Company will not be counted for the purpose.
- The tender will be received on 11.05.2009 upto 1.00 P.M. in the Office of the undersigned & Part-I will be opened at 3.30 P.M. on the same day in the Office of the undersigned in presence of tenderer or their authorised representative.
- The Management of BCCL reserves the right to reject any or all the tenders without assigning any reason whatsoever or to split up or distribute the work among the tenderers.
