#### 4 Eligibility Criteria

The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar civil works during last 7 (Seven) years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period should be either of the following:

- a. Three Standard hours completed work each cost estimate is 100% complete or equal to 40% of the estimated cost.

Two similar completed works each costing not less than amount equal to 50% of the estimated cost

One similar civil complaint with regard to the same matter was filed against the same defendant in the United States Court of Appeals for the Second Circuit.
