- a) The estimated amount of tender is Rs 4.32 Lac (Rupees Four Lac thirty two Thousand) only.
b) The cost of the tender document is Rs 100.00 (Rupees One Hundred) only (Non refundable)
c) The requisite amount of earnest money is Rs 4,320.00 (Rupees Four thousand three hundred twenty) only.
d) **Period of Contract:**

Period of contract will be six months.

e) **Eligibility Criteria:**

i) Vehicles permitted to be deployed on hire as Motor Vehicle Act only be offered for this purpose, i.e, the vehicles, which are registered for commercial use. However in case of successful bidders, whose vehicles are not registered as commercial vehicle as per MV act, will be issued "Letter of acceptance" initially with the condition that they must get their vehicles registered as commercial vehicle within a period of one month failing which their LOA will be cancelled. Final work order in such Cases, will be issued on production of commercial papers of the vehicle. In Cases of tenderer desires to deploy new vehicles, he should submit the self attested True copy of purchase deed/copy of the agreement with bank/ financier etc in case of hire purchase/installment basis. Also an undertaking from the dealer of the motor vehicle be submitted that they will deliver the vehicle within one month from the placing of order.

ii) Vehicles are to be road worthy and in good running condition and should be not more than 2 years old on the date of submission of tender. Date of original Registration will be deciding factor to determine the age of the vehicle. Copy of original Registration certificate must be submitted along with the copy of sale letter after LOA is issued in favour of the tenderor.

iii) Vehicle are required to be covered under appropriate insurance policy as per MV Act and must have paid upto date Road Tax/Permit fees etc as per MV Act. The driver of the vehicle must possess valid commercial driving license.

iv) All vehicles (Diesel Version) must have permit for the State of Jharkhand and west Bengal

1) Evolution:

i) In event of L/1 tenderer is having capacity constraints, the Techno-Commercially accepted L/1 rate will be counter offered to technically qualified L/2 and then to L/3 and so on in that order of original ranking till the requirement put to tender is met.

ii) In case of valid offers received will be exceeding the requirement in either L/1 or L/2 or L/3: ...and so on, order preference will be as under:

- 1) Year of Manufacturing, in case of more than one vehicle have same year of manufacturing, date of registration will be deciding factor.
- 2) Existing Transport contractor in BCCL.
