**NOTICE INVITING TENDER**

Sealed Tenders are invited from reputed electrode manufacturers / reclaimers in 2(two) bid system(TC bid and Price bid)for undertaking the following repair jobs of South Tisra OCP, Lodna Area -X, BCCL.

**Work involved are as follows :**

**A) Bucket Assy :**

- a) Cutting out the unwanted portion from the lip portion of Bucket.
- b) Repairing of Lip portion and vertical extension plate using Min. Steel plates of 25mm thick.
- c) Fabrication of the body of the Bucket as per original shape using Min. Steel plates of 25mm thick.
- d) Fabrication of sides of the Bucket using 25mm thick M.S. Plates.
- e) Repairing of Bracket of Trip Rope Thimble 1 No.
- f) Repairing of lower chain mounting using 25mm thick Min. Steel Plates.
- g) Fabrication of Channels all around the outer side of the bracket using 4"x 4" size M.S. Channels.
- h) Strengthening of inside of the Bucket by using 6" x 20mm M.S. Plate strips.
- i) Replacement of front shackle mounting using EN-19 Steel rounds.
- j) Making brackets using 20mm thick M.S. Plate and shoe fittings.
- k) Hard facing on the front half portion of the Bucket.

**B) Base Metallic Structure:**

- a) Approach to be made by removing the OB manually from the edge of the machine to the repairing point
- b) Cleaning of total Base.
- c) Cutting of damaged Base Plate segment by segment
- d) Straightening of vertical plates using gas heating and by hydraulic press.
- e) Replacement of bottom plates segment by segment using new 20mm thick Min. Steel Plates to the original size.
- f) Cutting of 10mm thick M.S. Plates in size 36 Nos., setting by gas heating and hammering by the side of the base and welding. Welding of clamps all round the base 72 Nos. for holding the trailing cable with 12mm dia M.S. Rods.
- g) Painting the total base with red oxide paint as first layer and two coats of varnish paint. Painting to be done by brush only.

1. Eligibility Criteria :-

a) The intending tenderer must have in its name experience of having successfully completed similar works during last seven years ending last day of month previous to the one in which bid applications are invited ( i.e. eligibility period ) should be either of the following :-

Three Similar completed works each costing not less than the amount equal to 40% of the estimated cost.

OR

Two Similar completed works each costing not less than the amount equal to 50% of the estimated cost.

OR

One Similar completed works each costing not less than the amount equal to 80% of the estimated cost.

**Similar works means :- Expertise in Special Alloy Steel Electrodes Welding**

b) Financial capacity:- Average annual financial turn over of work during the last three years ending 31<sup>st</sup> March of the previous year should be at least 30% of the estimated cost.

c) The Tenderer must submit documentary evidence in support of ( a ) & ( b ) above in the form of self certified copy of Work Order, Completion Certificate, Payment Certificate indicating the period of work for which the payment has been made.

d) ( i ) The offers are to be submitted in three parts. The first part "Part-I i.e. Techno Commercial Offer" should contained the detailed Technical & Commercial terms of the offer should contain Technical & Commercial terms and conditions, earnest money, experience credentials/ firm details of work order, Warranty / Guarantee clause, Xerox Copy of Sales Tax Registration - VAT / TTN , Service Tax Registration and latest copy if Income Tax returned filed along with PAN etc. However this should not contain the Price. The envelope should be sealed , super scripted with the tender number and the date of opening and must mark Part-I.

( ii ) The second part "Part-II i.e. Price Bid" should contain the details of price only. Rates are to be mentioned both in figures and words. The envelope should be sealed super scripted with the tender number and the date of opening and must mark Part-II

( iii ) Part - III ( Applicable for those participants who down load tender documents from our web site.

In this case the intending tender participant must enclose the requisite tender fee as Bank Draft from any nationalised Bank drawn in favour of "BCCL, Lodna Area-X, Expense A/C " payable at Dhanbad in the "Part -III" envelope. The envelope shall be sealed, superscripted with tender number and due date of opening and must mark " Part III".

All the envelopes containing the tender shall be properly sealed. The name and address of the bidder must also be indicated on the envelopes. Please note that envelopes stapled shall not be accepted.

All these three sealed envelope i.e. "Part-I" ( Techno Commercial bid ), "Part-II" ( Price bid ) and "Part-III" ( Requisite tender fee as indicated in the tender notice ) should be kept in a bigger envelope giving details of the tender number and due date and time of submission and opening along with the name and address of the tenderer.

In absence of "Part-III" envelope offer shall be rejected out rightly without any reference for those participants who have down loaded the tender documents from our web site.

"Part-I" ( Techno Commercial offer ) and "Part III" (Tender fee) will be opened on the due date of tender opening in presence of authorized representative of the attending tenderers.

NOTE :-

a) The tenderers are advised to inspect the above jobs of D/Line ESH 645 of South Tisra OCP, Lodna Area on any working day between 19.05.2009 to 13.06.2009. A Copy of Credentials has to be submitted to Engineer In-Charge (Excm.) N.E-GH OCP as documentary evidence.

b) Tender not submitted on the above manner will liable to be rejected.

c) If tender discloses their price in the Techno-Commercial bid( Part-I ), the offer will be re-sealed and will be treated as invalid offer by the Tender opening Committee.

The price bid i.e. "Part -II" of only those tenders whose Part-I is found to be Techno-Commercially acceptable to BCCI, will be opened later on. Date and time of opening will be suitably be intimated to such tenderers whose offer are found Techno-Commercially acceptable.

d ) All pages of tender documents should be signed including all enclosures submitted with the tenders except printed leaflets / catalogues and have company's seal. This is must otherwise offer shall be rejected.

e) Erased and over written quotations will be summarily rejected unless corrections are authenticated with the authorized signature.

f) Tenderer must have valid Sales Tax Registration / VAT / TIN , Service Tax Registration and latest copy if Income Tax returned filed along with PAN.

#### TERMS AND CONDITIONS :

1) Earnest money :- The earnest money may be deposited in the form of Bank Draft in favour of BCCI, Lodna Area-X, Expenses A/C on any nationalized Bank payable at its Dhanbad Branch, or may be deposited in cash at Cashier, Lodna Area Office and money receipt in original to be submitted along with the Part II Techno-Commercial offer) otherwise offer shall be considered unresponsive.

2) The price of tender document shall be Rs. 250/- for each job payable either in cash or Bank Draft drawn in favour of BCCI, Lodna Area-X, Expenses A/C on any nationalized Bank payable at its Dhanbad Branch. This will be non refundable.

If this Tender Document has been down loaded from our website Part-III envelope clause ( d ) ( iii ) bearing required Bank Draft for the requisite Tender fee must be enclosed along with the tender otherwise their offer shall be rejected out rightly without any reference.

3) The tender documents including terms and conditions of work shall be available on production of cash receipt / demand draft from the office of undersigned during any working day from 08.06.2009 to 13.06.2009

4) Completed sealed Tender document ( Part I & Part II & Part-III ) may be deposited in person by the tenderer in the Tender Box available in the Office Of the Area Manager(Excn.), Lodna Area on any working day between 9.30 A.M. to 5.0 P.M. and it will be accepted up to 15.06.2009, 1.00 P.M. Late submission of Tenders will not be considered. Part I will be opened on the same date i.e, 15.06.2009 at 5.00 P.M. in presence of intending tenderers or their authorized representatives. The Part II will be opened only after the Department is satisfied that the criteria fixed are fulfilled and also the earnest money is deposited.

5) The company is not under any obligation to accept the lowest tender or tenders and reserves the right to reject any or all tenders without assigning any reasons what so ever.

6) Tenderers may submit their offer for one or more job, but they are required to submit separate set of offer for each job.

**VALIDITY** :- The offer must be valid for acceptance for a period of 6(Six) months from the date of opening tender. Offers will not be permitted to be withdrawn during this period.

**PAYMENT TERMS** :- 90% payment will be made within 30 days after receipt of the job duly repaired successfully at our end and submission of the bill. Balance 10% payment will be released after successful completion of warranty period.

**PAYING AUTHORITY** :- Area Finance Manager, Lodna Area-X, BCCL

**WARRANTY** :-

Repaired job should be warranted for the period of 12 months from the date of fitment or 2000 working hours which ever comes earlier from the date of fitment.

**TRANSPORTATION ( TO AND FRO ) Men and Equipments both** :- It will be met by the repairer.

**FACILITIES TO BE PROVIDED BY THE BCCL** :-

I) crane with operator and required slings will be provided.

II) Electricity at work site.

III) Single point welding facility, if available (any other point welding facility will be responsibility of the L-1 repairer).

**INSPECTION** :-

Final Inspection of repaired job will be made by Engineer In-Charge(Excn.), NT-ST OCP, Lodna Area.

PENALTY :-

For any delay in completion of job 1% of the bill will be deducted for every one week delay or part thereof subject to maximum 5% of the total amount.

PERIOD :-

Completion period is 30(Thirty) days from the date of handing over the job for Item No.-( 1 ) i.e. Bucket Assy. and 45(Forty five) days for Item No.-(2 ) i.e. for Base Metallic Structure.

GENERAL :-

Payment to the worker engaged by contractor will be their responsibility as per prevailing Jharkhand State minimum wages act. The contractor should abide all safety rules, mine rules applicable to the mines as per mine act. This include training of contractors workmen under vocational training rules and providing safety appliances to workers. Liability of payment in respect of any accident to any workmen employed by contractor under the contract will be solely on their account and any expenses incurred by the department (BCL) in dealing with such matter will be recovered from the contractors bill.

All safety gadget like safety belt, helmet, leather apron, goggles, leather hand gloves, are to be provided by the contractor to the workmen engaged by them. Contractor will also arrange for supervision of work.
