Terms & Conditions :-

1. Tenderers must have a valid drug license & TIN Number. Tender must be accompanied with a copy of certificate of TIN No. & Valid Drug License duly attested by the tenderer and stamped (Seal)
2. Detailed Specifications of the material must be indicated in the Quotation i.e. Part – I of the bid.
3. The RATE must not under any circumstances be altered. Quotation with over writing of rates may be ignored.

4. The bids must be submitted in Two parts i.e. part I and part II. Part I must contain the documents regarding eligibility, specifications etc. The samples of the materials should be submitted in a separate envelope superscribed in the same manner. Part II or the price bid must indicate the price of each item per piece. Each of the bid will be superscribed as Part I or Part II on the respective envelopes.

The price quoted must be exclusive of Sales Tax Excise duty, VAT etc. The rates at which these taxes are applicable, must be mentioned separately. If Taxes are not mentioned separately it will be presumed that prices quoted are inclusive of all taxes. No changes will be entertained later on.

5. The terms of payment are : - 100% payment within 30 days from the date of receipt of and acceptance of the materials at the site i.e. Medicine Store of Regional Hospital Bhuli.
6. Only typewritten quotations should be submitted.
7. The Samples of the materials must be submitted free of cost in a separate envelope.
8. Your offer must be valid for at least 3 months/preferably six months.
