TENDER NOTICE

Sealed percentage rate tender in two parts (Part-I & II) are invited from experienced and eligible contractors for taking up the following works:-

Date & time of opening of Bid: 1.7.2009 at 3.30 P.M.

(In the event of the specified date for the submission opening of bids being declared holiday by the employer, the bids will be received/ opened on the next working day).

Tender documents can be obtained from the office of the Chief General Manager, Kustore Area, P.O. Jharia (Dhanbad) on any working day during office hours from 10.00 AM to 5.00 PM. Cost of tender document should be paid only in the form of Cash or Bank Draft drawn on Nationalized Bank in favour of BHARAT COKING COAL LIMITED payable at Dhanbad.

Completed sealed tender documents should be submitted in two parts (Part-I i.e. Technical/Commercial Bid and Part-II i.e. Price Bid) at the office of the Chief General Manager, Kustore Area, P.O. Jharia, (Dhanbad) up to 1.7.2009 by 3.00 P.M. Only Part-I will be opened on the above date. The Part-II will be opened only if the department is satisfied that the criteria fixed are fulfilled and also the earnest money is deposited i.e. on acceptance of Part-I.

The intending tenderer must have in its name, as a prime contractor, experience of having successfully completed similar works during last 7 (seven) years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period) any one of the following.

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

Or

Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

Or

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

Average annual financial turnover of civil work during the last 3 (three) years ending 31st March of the previous financial year should be at least 30% of the estimated cost.

Earnest Money @ 1% of the Estimated Cost shall have to be deposited with the AFM, Kustore Area in Cash or D.D. in favour of M/s. B.C.C.L.

Tenderer has to make his own arrangement of suitable materials/equipments and man power required in the work.

Tenderers are requested to quote their rate on percentage rate basis on the prescribed bill of quantity in word & figure.

Conditional tenders will not be accepted.

Issuance of tender documents does not mean that the parties are considered qualified.

It will be obligatory for the tenderers to keep their offer open for acceptance for a period of 120 days from the date of opening of the tender/ revised offers.


The Management of BCCL reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever.

Work done certificate to be submitted will be treated as experience. The photocopy of certificates should be attested by Project Officer / Colliery Manager.

Intending tenderers have to submit Permanent Account No.(PAN) & Income Tax Clearance Certificate and Sale Tax / TIN Registration details including Service Tax Reg.No. If Service Tax is readmissible by the Company (as per service tax Act) the Contractor produce proof of service tax deposit in Govt. Bank.

Successful tenderers has to deposit 5% of Work Awarded Value towards Performance Security to deposit with AFM, Kustore Area in Cash / DD/ Bank Guarantee in favour of M/s. BCCL within 28 days of the letter of Acceptance by the successful bidder.

It should be ensured that no contractor workmen is deployed on work without getting basic Safety Training as per Mine Vocational Training Rule under the supervision of Safety Officer of the mine. Record of such training is to be maintained in a register kept for the purpose.
