Or

Two similar completed works each costing not less than amount equal to 50% of the estimated cost.

Or

One similar completed work costing not less than amount equal to 80% of the estimated cost.

- b) Average annual financial turn over of Civil works during the last 3 (three) years, ending 31° March of the previous financial year, should be at least 30% of the estimated cost.
- c) Similar work means: Railway Track Maintenance.
- Note: (1) Provision under eligibility criteria No.1(a) shall also include those similar work which have been started earlier than eligibility period of tender but completed during the eligibility period as per N11.
  - (2) As per eligibility criteria specified under No.1 (a) Pre-qualification shall be done based on experience of successfully completed works and not on experience of work in progress.
