NOTICE INVITING TENDERS

Sealed tenders in two parts are invited on percentage above/below basis from bonafide, experienced and resourceful contractors for the following work :-

1. Construction of Boundary Wall for Coal Depot at Palasia Incline of Basanta Mitalia Colliery.	Rs. 3,37,720/-	Rs. 3,380/-	Rs. 250/-	Two Months.

Eligibility Criteria :

1. The intending tenderers must have in its name experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which bid applications are invited i.e. eligibility period should be either of the following -
  - a) Three similar completed works each costing not less than the amount equal to 40% of the estimated Cost  
OR
  - b) Two similar completed works each costing not less than the amount equal to 50% of the estimated Cost  
OR
  - c) One similar completed work costing not less than the amount equal to 80% of the estimated Cost.
2. Similar work means that the tenderer should have experience of Civil Construction or repairing works.
3. Average annual financial turn over of civil works during last three years ending 31st March of the previous financial year should be atleast 30% of the estimated cost.
4. Conditional tenders will not be accepted.
5. Tenderers are to submit separately in two Sealed Covers containing (i) Techno Commercial bid and (ii) Price bid. The techno commercial bid should contain the proof of eligibility criteria as fixed above the earnest money and details of TIN & PAN No. The part-I will be opened on 20.07.2009 at 3.30 P.M. The part-II containing the Price bid will be opened by the Committee only after acceptance of Part-I.
6. The tender documents can be had from the Office of A.C.E., CV Area from 16.07.09 to 18.07.09 during office hours only on writing request and production of credential in support of the eligibility for issuance of tender documents.
7. The experience given in the eligibility criteria should be in the name and style in which tender is filled. The experience of the partner if any, in name or firm/Company will not be counted for the purpose.
8. The tender will be received on 20.07.2009 upto 1.00 P.M. in the office of the undersigned & Part-I will be opened at 3.30 P.M. on the same day in the office of the undersigned in presence of tenderers or their authorised representative.

9. The Management of BCCL reserves the right to reject any or all the tenders without assigning any reason whatsoever or to split up or distribute the work among the tenderers.
10. The tender documents will be issued to the Prima-facie qualified parties based on the documents to be submitted by them along with the written request for tender documents. Issuance of the tender documents does not mean that the party is qualified.
11. Earnest Money will be refunded to the unsuccessful parties and bear no interest.
12. There will be no arbitration clause.
13. No tender will be issued or submitted by postal means.
14. The Earnest Money shall be deposited in form of Cash in the office of the Area Finance Manager, C/V Area or Bank Draft of nationalised Bank in favour of "Bharat Coking Coal Limited" payable at Barakar. The earnest money is to be deposited as per details given in the tender documents.
15. In case of contract for a period of more than six months, payment of wages to the contract workers through Bank Cheque.
16. Service Tax is applicable as per rule.
17. The tender will be valid for 120 days from the date of opening of price bid or revised price bid, whichever is later.
18. The tenderers have to submit Permanent Account Number of Income Tax (PAN) and documents relating to Sales Tax Registration/TIN in Techno Commercial bid.
