The intending tenderer must have in its name, as a prime contractor, experience of having successfully completed similar(UG)/ civil works during last 7 (seven) years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period) any one of the following.

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost

Two similar completed works each costing not less than the amount equal to 50% of the estimated cost. Or

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

- Average annual financial turnover of civil work during the last 3 (three) years ending 31" March of the previous financial year should be at least 30% of the estimated cost

- It should be ensured that no contractor workmen is deployed on work without getting basic Safety Training as per Mine Vocational Training Rule under Safety Officer of the mine. Record of such training is to be maintained in a register kept for the purpose.
- Successful tenderers has to deposit 5% of Work Awarded Value towards Performance Security to deposit with AFM, Kustore Area in Cash / DD/ Bank Guarantee infavour of M/s. BCCL within 28 days of the letter of Acceptance by the successful bidder
