Sealed item rate tender are invited from bonafide, reputed, competent and resourceful commercial vehicle operating firms/parties for engagement of following types of vehicles on hire basis inclusive cost of POL for deployment with CISF, Bastacolla Area of Bharat Coking Coal Ltd. as per details available in tender document. Tender will be received in two parts i.e. Part-I & Part-II.

Tender documents can be had from the office of the undersigned on written request on any working day from 20.7.2009 to 19.8.2009 on payment of requisite cost indicated above to be deposited in cash or any Bank draft on any Nationalised Bank in favour of Bharat Coking Coal Ltd., payable at Dhanbad with associate finance in Bastacolla Area up to 1300 hours on any working day except saturday i.e. 1200 hrs on saturday.

Tender will be received up to 15 hrs. on 21.8.2009 in this office. Part-I of the tender will be opened on the same day i.e. 21.8.2009 at 1530 hrs. in the office of the undersigned. The date of opening of Part-II will be communicated to eligible bidders later on after scrutiny of part-I.

Part-I should contain the technical terms such as partnership deeds, power of attorney, if any Earnest money, deposit, past Experience certificates and tender document containing general terms and conditions duly accepted by the bidder.

Part-II i.e. price bid should contain the B.O.D. issue to the tenderers with rate quoted by them. The rate offered in part-II should be valid for four months from date of opening of price bid or revised price bid.

The minimum eligibility criteria for the above mentioned work as under:-

- i) Only vehicles permitted (not older than 10 years on the date of opening of tender) to be deployed on hire as per Motor Vehicles Act. be offered for this purpose i.e. the vehicles which are registered for commercial use as per Motor Vehicles Act must be got registered for commercial use within one month from the date of issue of letter of intent and then only then the work order will be issued failing which letter of intent shall stand withdrawn.
- ii) Vehicles are required to be roadworthy and in good running conditions and should be not more than 10 (ten) years old on the date of opening of the tender. The vehicles to be provided with :-
  - Fog light during winter
  - Tool kit
  - First-aid box.
- iii) Vehicles are required to be covered under appropriate insurance as per MV Act and should have been paid upto date Road Tax/Permit fees etc. as per MV Act, as the case may be along with valid Registration.

- iv) The intending tenderers must have in its name as a prime contractor experience of having successfully completed similar works during last 7(seven) years ending last day of month previous to the one in which bid application are invited i.e. eligibility period onward be either of the following :-
- Three similar completed works each costing not less than the amount equal to 40 % of the estimated cost or
  - Two similar completed works each costing not less than the amount equal to 50 % of the estimated cost or
  - One similar completed works each costing not less than the amount equal to 80 % of the estimated cost.
- v) Evidence of possessing adequate working capital (at least 20% of the value of this work) inclusive of access to lines of credit and availability of other financial resources to meet the requirement.
- vi) Sub-contractors experience and resources will not be taken into account in determining the bidders compliance with qualifying criteria.
- vii) Bidder must indicate the number of vehicles he is offering for hiring vehicle submitting part-1 of techno commercial bid
- viii) Normally the vehicles should be owned by tenderer. in case vehicle is not owned by the tenderer, the details with Reg.No./Description and Notorised legat documents like power of attorney/lease document from the owner authorising the tenderer to ply the vehicle under contract is to be submitted.
- ix) The hire charges quoted per day shall be inclusive of diesel & lubricant. Payment of hire charges shall be made to the bidder to all days of engagement of the vehicles irrespective of the fact whether the vehicle is used by management or remains idle, unless instructed specifically otherwise. The hire charges should be including cost of maintenance & spares. Driver etc. all complete.
- x) The payment of running of vehicle shall be based on actual kilometers run as per log book maintained for this purpose and accepted by the controlling officer.
- xi) A recovery at the rate of double the awarded rate per day shall be done in case of bidder fails to provide the vehicle on a particular day of fails to provide replacement of breakdown vehicle.
- xii) Conditional tender will not be accepted. The work will not be subject to arbitration.
- xiii) All taxes applicable as per BCCL norms shall be borne by the contractor. The Contractor have to acquaint themselves with the site conditions before quoting their rates.
- The comp. any is not under any obligation to accept the lowest tender/tenders and reserves the right to reject any or all the tenders without assigning any reason whatsoever and also to distribute the work and allot the work/works to more than one tenderer at its sole discretion. All photocopies of valid papers should be self attested by the owner of vehicle.
