1. Sealed quotations should be submitted in the tender box of purchase department, Block-II Area, or should reach by post to Area Manager (MM) Block-II Area, BCCI, P.O. Nawagarh Dhanbad on or before 11.9.2009 by 1.00 p.m.
2. Offers to be submitted in 2 bids (Technical & price bids) in separately sealed envelopes. The technical bid must contain the following: TECHNICAL: 1. Copy of the PAN Card, 2. Copy of the Relevant Sales Tax registration. All documents submitted should be signed by the tenderer. Only offers from manufacturers/Authorised dealers/distributors/NSIC registered firms/Ancillary firms of subsidiaries of CIL/PSU/Govt undertakings will be accepted. Dealership certificate/NSIC certificate/Ancillary firm registration etc should be submitted.
3. Estimated value of the tender Rs. 2.40 lakhs
4. Tender fee Rs. 1000/- to be submitted separately in the form of Demand Draft in favour of Bharat Coking Coal Limited, payable at Dhanbad (non refundable). Only ancillary units ~~Public Sector Undertakings~~ are exempted from submission of tender fee.
