

1. Sealed quotations should be submitted in the tender box of purchase department, Block-II Area, or should reach by post to Area Manager (M&I), Block-II Area, BCCL, P.O. Nawagarh, Dhanbad on or before 15.9.2023, by 1.00 p.m.
2. Offers to be submitted in 2 bids (Techno commercial & price bids) in separately sealed envelopes. The techno commercial bid must contain the following. TECHNICAL: 1. The Description of items quoted, part no (if any) & quantity should be clearly mentioned 2. Only offers from DGMS approved manufacturers/their authorized dealers will be accepted. Copy of valid DGMS approval dealership certificate of DGMS approved firm must be submitted. The certificate should be attested by a Notary. COMMERCIAL: 1. Copy of the PAN Card 2. Copy of the relevant Sales Tax registration. All documents submitted should be signed by the tenderer. Hand written tenders & tenders without copy of valid DGMS approval/authorized dealership certificate of DGMS approved firm will be rejected outright.
3. Estimated value of the tender Rs : 1.50 lakhs (approx.).
4. Tender fee Rs. 1000/- to be deposited separately in the form of Demand Draft in favour of Bharat Coking Coal Limited, payable at Dhanbad (non refundable). Only ancillary units of Coal India Limited/Subsidiary Companies of CIL, PSU/Govt Companies are exempted from submission of tender fee.
