Eligibility Criteria

- The intending tenderers must have in its name experience & having successfully completed works during last 07 years ending last day of month previous to the one in which bid applications are invited i.e. eligibility period should be either of the following :-
  - Three similar completed works each costing not less than the amount equal to 40% of the estimated cost. OR
  - Two similar completed works costing not less than the amount equal to 50% of the estimated cost. OR
  - One similar completed work costing not less than the amount equal to 80% of the estimated cost.Similar works means Civil Works
- The tenderers must have average annual financial turn over in civil works during last three years ending 31st March of previous financial year should be atleast 30% of the estimated cost.
- Tenderers are to submit Permanent Income Tax Account & S.Tax Registration certificate as applicable along with tender. All other taxes shall be borne by the tenderer.
- Tenderers are to submit separately in Two Sealed Covers containing (i) Techno Commercial bid and (ii) Price Bid. The Techno commercial bid should be contained the proof of eligibility criteria as fixed over and also the Earnest Money Receipt. The Part- I will be opened by the Committee on 14.09.09. The Part- II containing price bid will be opened by the Committee only after the department is satisfied that the eligibility criteria fixed is fulfilled and also the Earnest money is deposited i.e. in accordance of Part- I.
- Rate is to be quoted in % above/below the estimated cost both in figure and words in BOLL prescribed forms.
- The Contractor have to acquainted with the site condition.
- All Taxes as applicable will be borne by the Contractor.
- Unless otherwise mentioned, no materials shall be issued by the Deptt.
- The tender should reach to the office of the undersigned on 14.09.09 upto 1.00 P.M. & will be opened in the same day at 3.30 P.M. (Part- I) in presence of tenderers or by their authorised representative.

11. 5% security Money will be deducted from R/A bill & shall remain at the disposal of the Company as Security ~~xxxx~~ ~~xxxxxxxxxxx~~ Money for satisfactory execution and completion of work in accordance with the provision of contract. Work ~~xxxx~~. The Security deposit amount shall not carry any interest. Other than security money, all R/A bill shall be paid 95% of work value. The balance 5% shall be paid along with final bill.
