1. Eligibility criteria: -

a) The intending tenderer must have experience in electrical & mechanical repairing of DC motor / generator of similar application & capacity. The firm having past experience in replacing armature shaft of DC machines only is also eligible to quote.

b) The firm should have work order for such type of work from any Govt/semi- Govt / PSU organization during last 3 (three) years, ending 31st March of the previous financial year, should be at least 60% of the estimated cost in any one financial year. Necessary documentary evidences are to be produced.
