**NOTICE INVITING TENDER**

Sealed tenders are invited under 2 (two) bid system containing part 1 (Technical Bid) and Part 2 (Price Bid) for engagement of 1(one) no Explosive Van on 24 hrs hiring basis, for a period of 6(six) months wef. 01.10.09 to 31.03.10 from reliable and reputed transport contractor for transportation explosives and accessories from Magazines of C.V. Area to different censing unit of C.V. Area and if necessary to mines / magazines other than C.V. Area as per instruction of C.V. Area authority.

Estimated amount of the tender is Rs 2, 16,580.00 (Hiring charge)

Cost of tender document is Rs.500/- (Rupees five hundred only)  
(Non refundable)

Requisite amount of earnest money is Rs 2166/- (Rupees two thousand one hundred sixty six only)

**Price and date of tender:-**

The application for the tender documents shall be Rs 500/-which is non refundable, payable either in cash with the cashier, C.V. Area, BCCL, Barakar and the money receipt thereof to be submitted to the tender issuing officer, for the purpose of getting tender paper submitted to the tender issuing officer, for the purpose of getting tender paper or by draft, payable in favour of BCCL, C.V. Area NO. XII on any scheduled Bank, Payable at Barakar.

Tender documents including general trams and conditions etc. shall be had from the office of the SOM C.V. Area, BCCL, on payment of requisite amount towards the cost of the same as mentioned above.

Last date of sell of tender paper date 15.09.09 up to 3 P.M.

Tenderer have to submit two separate envelopes duly sealed and marked Part I (Technical Bid) containing the proof of deposit of earnest money, experience, statutory papers etc. and the Part II (Commercial Bid) should contains the price bid for daily hiring charge on 24 hrs. hiring basis including all expenses except POL consumption.

Last date of submission of the tenders is 17.09.09 Till 3.00 P.M. date of opening of the part I (technical Bid) is 17.09.09 at 4.00 P.M. by the tender committee in presence of the attending bidders or their authorized representatives.

The part II (Commercial Bid) of the tenders shall be opened only in presence of the tenderer found successful on scrutiny by the tender committee.

**Eligibility critity of the tenders:-**

The vehicle offered to serve as Explosive van, must be:-

1. Licensed under the Explosive rules 2008 and meet the requirements as laid down in the Explosive Rules. The licensee of the explosive van shall maintain records of all transaction in form RE6 under part schedule 5 of Indian Explosive Rules 2008
2. The vehicle is requiring being road worthy in all respect and in good running condition. It should not be more than ten years old as on the date of the opening of the tender.

The tenderer shall engage only such driver and cleaners whose antecedents are verifier by local Police.

Normally the vehicle should be owned by the tenderer. However in case the vehicle is not owned by the tenderer the details Registration No , Description and ; Notarized Legal documents like power of attorney lease document of the owner authorizing the tenderer to ply the vehicles under his control is to be submitted.



3. Penalty :- Recovery at the rate of double the awarded rate per day shall be made in case the bidder fails to provide the vehicle on a particular day or fails to provide replacement of the breakdown vehicle.
4. No tender will be accepted without requisite amount of earnest money. Company reserves the right to reject any or all the tenders without assigning any reasons. Further details, terms & conditions are available in the tender documents.
5. The intending tenderers must have in his name and experience and having successfully completed similar nature(\*) of work in BCCL or any other Public Sector undertaking or Govt. firm, during last 7 years ending last day of the month previous to the one in which bid application are invited (i.e. eligibility period) should be either of the following: -
  - (a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.
  - (b) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.
  - (c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.
6. The tenderers have to keep their value for 120 days from the date of opening of the same which ever is later.
7. The tenderer have to abide fully by Labour Contract Act and all other State & Central Govt Acts as applicable.
8. The management may accept or reject or cancel the tender/s without assigning any reason what so ever.
- (\*) Similar nature work means transportation of any goods on hiring basis.
