1. Eligibility Criteria:

The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar/civil works during last 7 (0 even) years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period should be either of the following):

- Three Similar/civil completed work each costing not less than the amount equal to 40% of the estimated cost.

O:

Two similar completed work each costing not less than the amount equal to 40% of the estimated cost.

- a. One similar civil completed work costing not less than amount equal to 80% of the estimated cost.
- b. Average annual financial turn over at Civil works during the last 3 (three) years ending 31st March of the previous financial year, should be atleast 30% of the estimated cost.
- c. Similar work means: **Construction of buildingwork.**

In case where tender documents are requested for transmission by post, these would be dispatched by Registered A/D. The department is not responsible for any postal delay in such cases.

Late and delayed tenders, unsolicited post tender off the date of opening will not be accepted at all without any exception.

2. Only part-I will be opened on **24.9.2009**. The part-II will be opened only after the department is satisfied that criteria fixed are fulfilled and also the earnest money is deposited i.e. on acceptance of part-I.
3. Conditional tenders will not be accepted.
4. Issuance of tender documents does not mean that the parties are considered qualified.
5. The validity of the tender will be 120 days from the date of opening price bid or revised price bid if any.
