The intending tenderer must have in its name, as a prime contractor, experience of having successfully completed similar work during last 7 (seven) years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period) any one of the following.

Three similar completed work each costing not less than the amount equal to 46% of the estimated cost

Two similar completed work each costing not less than the amount equal to 50% of the estimated cost.

One similar completed work costing not less than the amount equal to 80% of the estimated cost

- Average annual financial turnover of civil work during the last 3 (three) years, ending 31" March of the previous financial year should be at least 30% of the estimated cost.
- Earnest Money @ 1% of the Estimated Cost shall have to be deposited with the AFM, Kustore Area in Cush or D.D. in favour of M/s, B.C.C.L

- The tender has to produce definite poof that he has at his disposal sufficient number of Payloaders & dumpers for carrying out the job specified in "Description of Work" of the Tender Notices mentioned above.
- It should be ensured that no contractor workmen is deployed on work without getting basic Safety Training as per Mine Vocational Training Rule under Safety Officer of the mine. Record of such training is to be maintained in a register kept for the purpose.
- Successful tenderers has to deposit 5% of Work Awarded Value towards Performance Security to deposit with AFM, Kustore Area in Cash / DD/ Bank Guarantee inflavour of M/s. BCCL within 28 days of the letter of Acceptance by the successful bidder.
