Cost of tender document should be paid only in the forms of cash or Bank Draft drawn from a Nationalized Bank in favour of BHARAT COKING COAL LIMITED payable at Dhanbad.

Completed sealed tender documents (Part-I and Part-II) i.e. technical/Commercial Bid and Price Bid should be submitted at the office of the Chief General Manager, Kustore Area, P.O.-Jharia (Dhanbad) on 7.10.09 at 1.00 P.M.

1. Eligibility Criteria:

The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar/civil works during last 7 (Seven) years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period should be either of the following):

a. Three Similar/civil completed work each costing not less than the amount equal to 40% of the estimated cost.

b. Two similar/completed works each costing not less than amount equal to 50% of the estimated cost.

Or

One similar/civil completed work costing not less than amount equal to 80% of the estimated cost.

b) Average annual financial turn over at Civil works during the last three years ending 31<sup>st</sup> March of the previous financial year should be atleast 30% of the estimated cost.

c) Similar work means Sl. No. 1 P.C.C. road S.L.No. 2& 3 Building works / Civil surface works

In case where tender documents are requested for transmission by post, these would be dispatched by Registered A/D. The department is not responsible for any postal delay in such cases.

Late and delayed tenders, unsolicited post bids, price lists and post tender revisions shall not be accepted at all without any exception.

2. Only part-I will be opened on 7.10.09. The part-II will be opened only after the department is satisfied that criteria fixed are fulfilled and also the earnest money is deposited i.e. on acceptance of part-I.
3. Conditional tenders will not be accepted.
4. Issuance of tender documents does not mean that the parties are considered qualified.
5. The validity of the tender will be 120 days from the date of opening price bid or revised price bid if any.
6. The management of BCCL reserves right to reject any or all the tenders without assigning any reason what so ever and to split up and distribute the work amongst the tenderers.
7. The tenderers can go through the standard tender document kept in the office of the undersigned before quoting their rates. The work will be carried out on terms and conditions contained in the NIT and standard tender document.
