2. The tender documents can be had from the office of ACE (EWZ) after Depositing of requisite cost of tender paper in form of cash (Non Refundable) with cashier/FM of EWZ from 06/11/09 to 10/11/09
3. **ELIGIBILITY CRITERIA:**

- a) The intending tenderer must have in its name as a prime contractors experienced of having successfully completed similar works during last 7 (seven) years ending last day of Month previous to the one in which bid applications are invited (i.e. eligibility period) should be either of the following:

Three Similar completed work each costing not less than the amount equal to 40% of the estimated cost.

OR

Two Similar completed work each costing not less than amount equal to 50% of the estimated cost.

OR

One similar completed work costing not less than amount equal to 80% of the estimated Cost.

Average annual financial turn over of Civil Works during the last 3 (three) years ending 31 st March of the previous financial year, should be at least 30% of the estimated cost.

Note: Provision under eligibility criteria specified under Sl. No. 1 also included those similar work which have been started earlier than eligibility period of tender but Completed during the Eligibility period as per NIT.

4. As per eligibility Criteria specified under sl. No. 1 pre-qualification shall be done based on experience of the successfully completed works and not on work in progress.

5. Earnest Money is to be deposited with the Associates Finance in shape of Cash or Bank Draft drawn on any Nationalised Bank in favour of Bharat Cocking Coal Limited Payable at Dhanbad.
