Completed sealed tender documents (Part-I and Part-II) i.e. technical/Commercial Bid and Price Bid should be submitted at the office of the Chief General Manager, Kustore Area, P.O.-Jharia (Dhanbad) on 29.10.09 at 1.00 P.M.

1. Eligibility Criteria :

The intending tenderer must have in its name as a prime contractor experience of having successfully completed similar/civil works during last 7 (Seven) years ending last day of month previous to the one in which bid applications are invited (i.e. eligibility period should be either of the following:

- Three Similar/civil completed work each costing not less than the amount equal to 40% of the estimated cost.

Or

Two similar completed works each costing not less than amount equal to 50% of the estimated cost.

Or

One similar/civil completed work costing not less than amount equal to 80% of the estimated cost.

- b. Average annual financial turn over at Civil works during the last 3 (three) years, ending 31<sup>st</sup> March of the previous financial year, should be atleast 30% of the estimated cost.
- c. Similar work means: **Item No-1 Road works**  
**item No-2 P.C. Road works.**

Incase where tender documents are requested for transmission by post, these would be dispatched by Registered A/D. The department is not responsible for any postal delay in such cases.
