2. Offers to be submitted in 2 bids (Techno commercial & price bids) in separately sealed envelopes. The techno commercial bid must contain the following. TECHNICAL: 1. Evidence of supply of SAME/SIMILAR items to any subsidiary of CIL/any PSU/Govt. Company or reputed private company (Order copies should be supported with evidence of actual supply against order). 2. The make of bearings should be mentioned. Offers for only Timken/SKF/FAG/NTN/NSK/Koyo make of bearings will be accepted. 3. The source of the bearing quoted should also be mentioned. 4. Tenderers should certify that the quoted item will conform to the OEM part number & will fit properly without without necessitating any modifications to the existing system of the equipment. 5. The items quoted/Part number if any & quantity should be clearly mentioned. 6. Only offers from manufacturers/authorized dealers/authorized distributors/direct importers of bearings will be accepted. Copy of valid authorized dealership/distributorship certificate/import licence certificate must be submitted. The certificate should be attested by a Notary. COMMERCIAL: 1. Copy of the PAN Card. 2.
