

1. Eligibility: The tender must have experienced of similar work during last seven years ending last day of the previous to the one in which tenders are invited should be any one of the following:

- i) Three similar completed works each costing not less than the amount equal to estimated cost.
- ii) Two similar completed work not less than the amount equal to 50% of the estimated value.
- iii) One similar completed work each costing not less than the amount equal to 80% of the estimated cost.
- 2. Average annual financial turnover during the last financial year ending 31st March of the previous financial year should be atleast 30% of the estimated cost.
- 3. Security deposit and performance guarantee 10% including earnest money of work order amount to be deposited within 10 days of issue of work order by the qualified tenders. The earnest money will be retained as performance guarantee which will be released after satisfactory completion of warranty period.
- 4. The tenders must have valid sale tax registration/VAT/TIN/Service Tax registration and latest copy of Income tax return filed along with PAN.
- 5. Payment : 100% will be made after satisfactory completion work on submission of bill.
- 6. Safety precaution should be taken by the repairer. Safety aspect will be sole responsibility of the repairers. The contractors person must trained at VTC and their names/attendance must be marked in form B/D/E before engaing them in mines.
- 7. The earnest money can be deposited in form of cash to area Finance Manager, Block II Area or in the shape of DD/Bankers cheque in favour of Bhart Coking Coal Limited payable at Dhanbad issued from any nationalized bank will also be accepted.

Sealed tenders are invited from reputed and experienced contractor/ repairer in two bids (TC bid and price bid) system for under-mentioned following repair job of Block-II Area of BCCL as per terms and conditions mentioned hereunder-

Repairing of 8300nos of Boom Pulley assy of P&H 87Shaper

- 2) Eligibility - The tenderer must have experience of successfully completed same/similar work during last seven years ending last day of the month previous to the one in which tenders are invited should be any one of the following:
i) Three same/similar completed works each costing not less than the amount equal to 40% of the estimated cost.
ii) Two same/similar completed works each costing not less than the amount equal to 50% of estimated cost.
iii) One same/similar completed work costing not less than the amount equal to 80% of the estimated cost.
.3) Average annual financial turn over during last three years ending 31st March of the previous financial year should be at least 30% of the estimated cost.

- 4) The tenderer must have valid sale tax registration/VAT/TIN, service tax registration and latest copy of income tax return filed along with PAN

- 5) Scope of work As given in estimate

5) Estimated value-Rs 175600/-

- 6) Earnest money- 1% of estimated cost to be deposited in cash with cashier ,Block-II area or demand draft /Banker's cheque of any nationalized bank in favour of 'Bharat Coking Coal Limited' payable at Dhanbad.Earnest money of all the tenderers will be refunded on application after finalization of tender except the qualified tenderer .

- 7) Warranty- 2500 working hours or 12 months from the date of commissioning in the m/c whichever comes earlier against poor workmanship and poor quality of materials.

- 8) Payment - 100% payment will be made after satisfactory completion of work on submission of bill.

- 9) Completion period—Within 20 days from the date of placement of work order or handing over the job whichever is earlier.

- 10) If any repaired assembly fails during warranty period, the repairer will have to repair the same free of cost .If any new item fails ,the same will have to be replaced with new by the repairer free of cost.

- 11). Safety precaution should be taken by the repairer. Safety aspect will be the sole responsibility of the repairer. The contractor persons must be trained at V.I.C and their names/attendances must be marked in form 'B/D/B' before engaging them in m/c.

- 12)L.D.Charge- Liquidity damage will be charged @ ½ % per week or part thereof subject to maximum 10% of the total work order value for delay in completion of work.

- 13) Validity of offer- 4 months from the date of tender opening

- 14) Security deposit and performance guarantee- 10% of work order amount to be deposited within 10 days of issue of work order by qualified tenderer. The earnest money will be retained as security money ,the qualified tenderer will have to deposit additional amount. After completion of work ,this amount will be retained as performance guarantee which will be released after satisfactory completion of guarantee period.

- 15) Right to accept or reject any or all tender is reserved without assigning any reason thereof.

- Note: i) tenderers are advised to inspect the m/c at working site of the project on any working day and be acquainted with the job in consultation with Engineer Incharge(X) /Area Manager (Exco) before submitting their offers

- (ii) All the documents /offer submitted must be signed by tenderer .

- (iii) Rates must be written both in figures and words. Government taxes may be deducted at source as per rule/guide line

- iv) All materials and tools & tackles along with manpower required for the above work will be arranged by repairer at their own cost. Crane will be provided by BCCL where ever required.

- (v) Offer must be submitted in two bid system.

The first envelope (ENVELOPE-1 /TC BID) should contain a)valid Sale tax registration/VAT/TIN,b)latest income tax return filed along with PAN ,c) Service tax registration d) Certificate regarding turnover/financial adequacy ,e)Work order copies along with completion certificate /certified bill copy claiming an experience ,f)Earnest money ,g)Tender document with signature of tenderer as acceptance of terms and conditions .
Tender may be rejected if required documents are not enclosed. Tenderers are advised to do their own page numbering and also enclose the list of enclosures.

The second envelope (ENVELOPE-2 /PRICE BID) should contain price bid only with price break up.

v) All the envelopes must be super scribed with the tender notice no , name of work and envelope no on each envelope of the offer. Both the envelopes must be sealed and must be submitted at the same time.

vii)Tenders shall be received on or before 20.11.05 up to 1.00 P.M. & TC BID (Envelope-1) will be opened at 3.00 P.M. on the same day .

Price bids (envelope -2) of qualified tenderers will be opened later on with intimation to tenderers by post /fax and notice board Block-II Area.

viii) Tenderers or their authorized representatives are advised to attend the tender opening process on scheduled date and time.
