

## TERMS & CONDITIONS

1. Sealed quotations should be submitted in the tender box of purchase department, Block-II Area, or should reach by post to Area Manager (MM), Block-II Area, BCCL, P.O. Nawagarh, Dhanbad on or before... 13.2.2009... by 1.00 p.m.
2. Offers to be submitted in 2 bids (Techno commercial & price bids) in separately sealed envelopes. The techno commercial bid must contain the following. **TECHNICAL:** 1. Evidence of supply of SAME/SIMILAR items to any subsidiary of CIL/any PSU/Govt. Company or reputed private company (SUBMISSION OF ONLY ORDER COPY WILL NOT BE ACCEPTED. TENDERERS SHOULD ALSO SUBMIT EVIDENCE OF ACTUAL SUPPLY OF MATERIALS AGAINST ORDER). 2. The make of bearings should be mentioned. 3. Only offers from manufacturers/authorized dealers/authorized distributors/authorized importers of bearings will be accepted. Copy of authorized dealership/distributorship certificate must be submitted. 4. The source of the bearing/country of origin of quoted item should also be mentioned. 5. A certificate should be given that the quoted item conforms to the OEM part no. 6. The tenderer should also certify that the items quoted will fit properly without necessitating any modifications to the existing system of the equipment.
