c. Tenderers should submit copy of their VAT / TIN Number.

- d. Tenderers should submit copy of valid approval/license issued by legal Metrology Department (Weights & Measure) Govt. of Jharkhand.
- e. The Tenderer need to inspect the Rail Weigh Bridge No.-III at Patherdih Yard, Lodna Area prior to submission of there offer. VERIFICATION OF THE WEIGH BRIDGE: The tenderer will be responsible for verification of the Road Weigh Bridge from Inspector, Weights & Measure, Legal Metrology, Govt of Jharkhand, Dhanbad.

GENERAL
