ELIGIBLE CRITERIA:

- 1.(A) The intending tender must have in its name & style as a prime contractor experience of having successfully completed similar works during last 7(Seven) years ending last day of the month previous to the one in which bid applications are invited (i.e. eligibility criteria) should be either of the following :-

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

OR


Two similar, completed of works each costing not less than the amount equal to 50% of the estimated cost.

OR

One similar, completed work costing not less than the amount equal to 80% of the estimated cost.

- (B) Average annual financial turn over of civil work during the last 3(Three) years, ending 31st March of the previous financial year, should be at least 30% of the estimated cost.

10. Tenderers should certify that neither he/they is/are employee of BCCL, nor related in any way/or, closely to any employee of BCCL & or the documents/credentials submitted by them are correct and not fictitious or false.
