2. PAYMENT : 30 days against SRV after receipt and acceptance of materials at Regional Store, Barora.
3. Sales Tax Registration No.(Central & State) should be submitted alongwith quotations(photocopy).
4. SECURITY DEPOSIT: Successful Tenderer should deposit security money in the form of Bank Draft @ 10% of the awarded value(for successful tenderer 2% Earnest money deposit will be considered towards security deposit) of the purchase order within 7(seven) days of the issue of the purchase order.
5. Sealed quotations should be submitted in the Tender Box of Purchase Department, Barora Area or should reach by post to Area Manager(MM) Barora Area, BCCL, PO:Nawagarh, Dhanbad on or before 26-2-2009 at 1.00PM.
