SECURITY DEPOSIT: Successful Tenderer should deposit security Money in the form of Bank Draft @ 10% of the ~~quoted~~ awarded value (for successful tenderer 2% Earnest money deposit will be considered towards security deposit) of the purchase order within 7(seven) days of the issue of purchase order.
