Tenders will be received upto 1500 Hrs.on 20.3.09 in this office, Part-I of the tenders will be opened on the same day i.e. 20.3.09 of 1530 Hrs.in this office of the undersigned.The date of opening of part-II will be communicated to eligible tenderers later on after scrutiny of part-I.

Part-I should contain the technical terms such as partnership deed, power of attorney, if any earnest money deposit, past experience certificate and tender documents containing general terms and conditions duly accepted by the bidder.

Part-II i.e.price bid should obtain the BOQ issued to the tenderers with rate quoted by them.The rate offered in part-II should be valid for four months from date of opening of price bid or revised price bid.

The minimum eligibility criteria for the above mentioned works as under:-

1.The intending tenderer must have in its name as a prime contractor -or experience of having successfully completed similar works during during last 7 (seven) years ending last day of month previous to the one in which bid applicable are invited'(i.e.eligibility period)should be either of the followings.

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

OR

Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

OR

One similar completed works each costing not less than the amount equal to 80% of the estimated cost.

Similar works means having done misc. Civil Surface work involving major RCC work for Sl.No.1, for Sl.No.2 having done pipe line works, & sl.No.3 & 4 similar nature of underground works.

The earnest money may be deposited with the associate finance in shape of cash or demand draft drawn on any Nationalised Bank in favour of Bharat Coking Ltd. payable at Dhanbad. The earnest money shall not bear any interest and shall be refunded to the unsuccessful tenderers after finalisation of tender and award of work.

All taxes applicable as per ECCL norms shall be borne by the contractor

No materials will be supplied by department. The contractor has to arrange all equipment required for completion of the work of his own cost.

Conditional tender will not be accepted. The work will not be subjected to arbitrations.


The tenderers are required to obtain labour licence from office of the AIC, Dhanbad under contract labour (Regulation and Abolition) Act-1970 if required after award of work.

The tenderers are required to submit Income Tax (PAN No.) TIN No. and affidavit in technical bid i.e. part-I.

The NIT with general terms and conditions and as adopted by ECCL norms from time to time will be form part of contract documents.

The contractor have to acquaint themselves with the site conditions before quoting their rates.

The management of ECCL reserves the right to reject any or all the tenders without assigning any reason what-so-ever and split up and distribute the work among more than the contractor. The decision of the management shall be final and conclusive.
