- Note: 1) Provision under eligibility criteria under SI. No.2 shall also include those similar works that have been started earlier than eligibility period of tender but completed during the eligibility period as per NIT.

2) As per eligibility criteria specified under SI. No.2 prequalification should be done based on experience of the successfully complted works and not on

experience of works in progress.
