1) Eligibility -The tenderer must have experience of successfully completed similar work during last seven years ending last day of the month previous to the one in which tenders are invited should be any one of the following-

i)Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

ii)Two similar completed works each costing not less than the amount equal to 50% of estimated cost.

iii)One similar completed work costing not less than the amount equal to 80% of the estimated cost.

2)Average annual financial turn over during last three years ending 31st March of the previous financial year should be at least 30% of the estimated cost.

3) Security deposit and performance guarantee- 10% (including earnest money) of work order amount to be deposited within 10 days of issue of work order by qualified tenderer. The earnest money will be retained as security money, the qualified tenderer will have to deposit additional amount. After completion of work, this amount will be retained as performance guarantee which will be released after satisfactory completion of guarantee period

4)The tenderer must have valid sale tax registration/VAT/TIN, service tax registration and latest copy of income tax return filed along with PAN

5) Payment - 100% payment will be made after satisfactory completion of work on submission of bill

6) Safety precaution should be taken by the repairer. Safety aspect will be the sole responsibility of the repairer. The contractor persons must be trained at VTC and their names/attendances must be marked in form 'B/D/E' before engaging them in mines

7) The details of job, terms and conditions will be available in tender documents.

8)The tender documents can be had from the office of Area Manager (Excv), Block-II Area on submission of cash of requisite amount to Area Finance Manager, Block-II Area or demand draft /banker's cheque of requisite amount in favour of 'Bharat Coking Coal Limited' payable at Dhanbad issued from any nationalized bank. Item of work- Repairing of bucket assy of P&H shovel of BOCP.

Eligibility -The tenderer must have experience of successfully completed similar work during last seven years last day of the month previous to the one in which tenders are invited should be any one of the following:-
similar completed works each costing not less than the amount equal to 40% of the estimated cost.
similar completed works each costing not less than the amount equal to 50% of estimated cost.

similar completed work costing not less than the amount equal to 80% of the estimated cost
The similar work stands for HEMM repair etc.

average annual financial turn over during last three years ending 31st March of the previous financial year should be at least 30% of the estimated cost.

Tenderer must have valid sale tax registration/VAT/TIN, service tax registration and copy of income tax return filed along with PAN

Item of work-

Repairing of bucket assy of P&H shovel of BOCP.

Estimated cost- Rs 192000/-

Earnest money- 1% of estimated cost to be deposited in cash with cashier, Block-II area or demand draft /Banker's order of any nationalized bank in favour of 'Bharat Coking Coal Limited' payable at Dhanbad. Earnest money of all tenderers will be refunded on application after finalization of tender except the qualified tenderer. The earnest money of qualified tenderer will be retained as security deposit, completion of work.

Warranty--1500 working hours or 12 months from the date of commissioning in the m/c whichever comes earlier in case of poor workmanship and poor quality of materials.

Payment - 100% payment will be made after satisfactory completion of work on submission of bill.

Completion period- 20 days from the date of placement of work order or handing over the job whichever is earlier.

If repaired assembly fails during warranty period, the repairer will have to repair the same free of cost. If any component fails, the same will have to be replaced with new by the repairer free of cost.

Safety precaution should be taken by the repairer. Safety aspect will be the sole responsibility of the repairer. The contractor must be trained at VTC and their names/attendances must be marked in form 'B/D/E' before engaging them in mines.

2. Clause- Liquidity damage will be charged @ 1/4 % per week or part thereof subject to maximum 10% of the work order value for delay in completion of work.

Validity of offer- 4 months from the date of tender opening

Security deposit and performance guarantee: 10% (including earnest money) of work order amount to be deposited 10 days of issue of work order by qualified tenderer. The earnest money will be retained as security money, the tenderer will have to deposit additional amount. After completion of work, this amount will be retained as performance guarantee which will be released after satisfactory completion of guarantee period.

Right to accept or reject any or all tender is reserved without assigning any reason thereof.

i) Tenderers are advised to inspect the m/c at working site of the project on any working day and be satisfied with the job in consultation with Engineer Incharge /Area Manager (Excv) before submitting their

ii) the documents /offer submitted must be signed by tenderer.

Rates must be written both in figures and words. Government taxes may be deducted at source as per rule/guide

iii) materials and tools & tackles along with manpower required for the above work will be arranged by repairer at own cost. Crane will be provided by BCCL where ever required.

Offer must be submitted in two bid system.

Envelope (ENVELOPE-1 /TC BID) should contain a) valid Sale tax registration/VAT/TIN, b) latest income tax return along with PAN) Service tax registration d) Certificate regarding turnover/financial adequacy, e) Work order copies along with completion certificate /certified bill copy claiming as experience, f) Earnest money, g) Demand /Bankers cheque of requisite amount for tender document if downloaded from website, h) Tender document with signature of tenderer as acceptance of terms and conditions,

or may be rejected if required documents are not enclosed. Tenderers are advised to do their own page numbering and also enclose the list of enclosures.

second envelope (ENVELOPE-2 /PRICE BID) should contain price bid only with price break up.

Both envelopes must be super scribed with the tender notice no, name of work and envelope no on each cover of the offer. Both the envelopes must be sealed and must be submitted at the same time.

Tenders shall be received on & before 25.2.09, up to 1.00 P.M. & TC BID (Envelope-1) will be opened at 3.00 on the same day.

Bids (envelope -2) of techno commercially qualified tenderers will be opened later on with intimation to tenderers by post /fax and notice board Block-II Area.
