Security Money: Successful Tenderer are required to deposit Security Money in the form of "BANK DRAFT" only of any scheduled Bank drawn in favour of "BHARAT COKING COAL LIMITED:, Expense A/C Lodna Area" payable at "DHANBAD", of 10% value of order (value means F.O.R destination price) within 15 days of receipt of order.
