## **TERMS & CONDITIONS:**

#### **GENERAL**

- 1. Quotation should be **Firm, F.O.R Destination** including risk in transits up to Lodna Regional Stores.
- 2. Price Quoted should be valid for minimum period of 120 days from the date of opening of quotations.
- 3. Quotation should be free from corrections & erasures. Only type written offer is acceptable.
- 4. Sealed quotation must be submitted in the Tender Box of Purchase Deptt. Lodna Area, Area X ,. BCCL.
- 5. Techno- Commercial-Bid will be opened on due date & time as mentioned above. Price Bids of only those Tenderers whose Techno-commercial bid is found to be acceptable will be opened later on.
- **6. Payment Terms :** 100 % after receipt, inspection and acceptance of material at Lodna Regional Store and submission of final bill ( whichever is latter) within 30 days.
- 7. Delivery: To be completed within 45 days from the date of issue of formal order.
- 8. Tenderers must mention **C.S.T. No. & State Sales Tax Registration No. / VAT No. / TIN No.** in Techno-commercial bid and self- authenticated copies of same to be submitted in Techno-Commercial Bid.

- 9. Cost of tender document Rs. 1000/= in the form of Bank draft in favour of "Bharat Coking Coal Ltd, Expense A/C Lodna Area" Payable at "Dhanbad", must accompany Techno commercial bid, if downloaded from website. Intending Tenderer by depositing cash Rs1000/= can purchase tender document in Area cash section and submission of original money receipt in area Purchase Section.
- 10. Earnest money: An earnest money of Rs. 17523/=(Rs. Seventeen Thousand five hundred twenty three only) in the form of "Bank draft" in favour of "Bharat Coking Coal Ltd. Expense A/C Lodna Area" payable at "Dhanbad", must accompany techno commercial bid, otherwise offer will not be considered for further evaluation. For unsuccessful Tenderer, earnest money shall be refunded immediately after finalization of the tender.

- **13. Price Fall & L.D.Clause** acceptance must be given in the offer.
- **14.Guarantee: 6(Six)** months from the date of supply.
- **15**.Tenderrs must submit in techno commercial bid self attested copies of purchase orders received from subsidiaries of CIL including BCCL/ Govt. Organization during last three financial year including current financial year for the same items. Minimum no. of such purchase orders should not be less than two(02).

# **Technical specification & other Terms & Conditions**

- 1. The cement capsules shall be of DGMS approved type as per letter no. DGMS(Tech)/(S&T) circular no. 3/703 dt. 14.08.08 and further approval accorded by DGMS individually to the firms for manufacture. Self authenticated copies of valid DGMS approval for the Tenderes must submit manufacturing of quick setting type cement capsule in Techno commercial bid.
- **2.Cement capsules shall** be quick setting type of size: 32mmx400mm,weighing 400grm approx. & 25mmx300mm,weighing 250grm approx.each.
- 3. The cement capsules when used with roof bolt in under ground mine it shall provide a minimum anchorage of three (03) Ton after 30 minutes and five (05) ton after 2 hours of setting.
- 4. The self-life of cement capsule shall be minimum six (6) months from date of supply.
- **5.**The cement capsule shall be packed suitably with batch no. and month of manufacturer.
- 1. Batch test certificate to be submitted with supply of cement capsule as per DGMS approval accorded to the firms.

BCCL reserves the right to accept or reject any or all of the offers, extend tender opening, modify tender document or cancel the tender without assigning any reason.

Tender document can be either downloaded from BCCL website or can be obtained from Purchase department, Lodna Area, BCCL on all working days till 1PM up to two days prior to due date of opening.
