1.Eligibility: The tender must have experienced of similar work during last seven years ending last day of the previous to the one in which tenders are invited should be any one of the following:

- ii) Two similar completed work not less than the amount equal to 50% of the estimated value.
- iii) one similar completed work each costing not less than the amount equal to 80% of the estimated cost.

iv) Tender should submit the supply order proof of estimated value at least.

2. Average annual financial turnover during the last financial year ending 31st March of the previous financial year should be atleast 30% of the estimated cost.

3.Security deposit and performance guarantee 10%(including earnest money of work order amount to be deposited within 10 days of issue of work order by the qualified tenderers
The earnest money will be retained last performance guarantee which will be released after satisfactory completion of warranty period,

Sealed tenders are invited from experienced reputed Electrode manufacturers/ dealers in two bid (TC bid & price bid) system for undertaking the following job of Block II Area of BCCL as per terms & conditions mentioned hereunder:

1. Name of work: Repairing of bucket of P&H 89 shovel of JOCP....
2. Eligibility: :The tender must have experience of successfully completed same /repair of teeth should be any on the following:
 - i)Three similar completed works each costing not less than the amount equal to 40% of the Est, cost,
 - ii)Two similar completed works each costing not less than the amount equal to 50% of the Est, Cost.
 - iii)One similar completed works each costing not less than the amount equal to 80% of the Est, Cost
 - iv) Tenderers should submit the supply order proof of estimated value atleast..
- 3 Average Annual Financial Turn over during last three years ending 31st March of the previous financial year should be at least 30% of the estimated cost.
- 4.The tender must have valid Sales tax registration/VAT/TIN/Service tax registration alongwith latest copy of Income tax return filed alongwith PAN.
5. Scope of work as given in the estimate
- 6.Estimated value Rs: 188054/-
7. Earnest money 1% of the estimated cost to be deposited in cash with cashier, Block II Area or demand draft/Bankers cheque of any nationalized bank in favour of BHART COKING COAL LIMITED payable at Dhanbad, the earnest money of all the tenders will be refunded on application after finalization of tender except the qualified tenders.
- 8..Warranty 2500 working hours or 12 months from the date of commissioning in the machine whichever comes earlier against poor work man ship and poor quality of materials.
- 9.completion period---within---10 days from the date of placement of final order or handing over the job whichever comes earlier.
- 10.If any repaired assy/ sub assy fails during warranty, the repairer will have to repair the same free of cost. If any new items fails the same will be replaced with new by repairer free of cost.
- 11.Safety precaution should be taken by the repairer. Safety aspect will be the sole responsibility of the repairer.The contractors person must be trained at VTC and their names/attendance must be marked in form B/D/E before engaging them in mine.
- 12.L.D.Clause: Liquidity damage will be charged @ ½ % per week or part there of subject to maximum 10 % of the total work order value for delay in completion of work.
- 13Validity: -4 month from the date of opening of tender..
- 14.Security deposit & performance guarantee:-10 % of the work amount to be deposited within 10 days of issue of work order by qualified tenderers.The earnest money will be retained as security money,the qualified tenderer will have to deposit additional amount. After completion of work this amount will be retained as performance guarantee which will be released after satisfactory completion of guarantee period.
15. Right to reject/accept any or all tender without assigning any reason thereof.
 - i) Tenderers are advised to inspect the machine at working site of the project on any working day and be acquainted with the job in consultation with the Engineer Incharge(Excv)/Area Manager(Excv) before submitting the offer.
 - ii) All the documents submitted must be signed by the tenderers.
 - iii) Rates must be written both in figure and words.. Government taxes must be deducted at source as per rule/guideline.
 - iv)All materials tools & tackles along with man power required for the above work will be arranged by the repairer at their own cost. Crane will be provided by the BCCL wherever is required.

v)The first envelop (TC bid) should contain i) Valid sales tax registration/VAT/TIN b) latest Incom tax return files alongwith PAN c) Service Tax registration d) Certificate regarding turnover financial adequacy e)Work order copy along with completion certifiicate and certified bill copy claiming as experience f) Earnest money g) Tender document with signawture of tenderers as acceptance of terms & conditons.

Tender may be rejected if required documents are not enclosed.Tenderers are advised to do their own page numbering and also enloed the list of enclosures.

The second envelop(Price bid) should contain price bid only with price break up.

vi) All the envelops must be superscribed with the tender notice no. name of work and ennvelop no. on each envelop of the offer.Both the envelop must be sealed and must be submitted at the same time .

vii) Tender shall be received on or before 16.3.10 up to 1.p.m. & TC Bid will be opened on the same day at 3.00 p.m. Price bid envelop of the qualified tenderers will be opened later on with intimation to temderers by post/fax/notice board,Block II Area.

viii) Tenderers or their authorized representatives are advised to attend the tender opening process on scheduled date and time
