- a) The estimated amount of Tender is Rs.05.11 Lakhs approximately
- b) The cost of Tender document is Rs.100/-(Rupees One hundred) only (non-refundable)
- c) The requisite amount of earnest money is Rs.2555 -(Rupees Two thousand Five hundred Fifty five) per vehicle, to be deposited to Area Finance Manager, Katras Area.
- d) Period of Contact:-
Tender is being invited for the period of 2 years. Management reserves the right to terminate the contract will prior notice of one month.
- e) The validity of the tender will be 120 days from the date of opening of price Bid or revised price bid, if any.
- f) The complete bid documents will be available on the website for the purpose of downloading and tender submitted on such downloaded bid documents shall be considered valid for participating in the tender process.
- g) The company shall not be responsible for any delay/difficulties/inaccessibility of the downloading facility for any reasons whatsoever. The downloading facility shall be available during the period of sale of tender paper.
- h) The bidders, who will download the tender documents from the website of The company, will be required to pay the cost of tender paper (Application fee) by Bank Draft as per NTT at the time of submission of tenders.
- i) The bidders will be required to submit an undertaking that they will accept



the tender documents as available in the website and their tender shall be rejected, if any tampering in the tender documents is found to be done at the time of opening of tender.

- j) The Bank Draft towards the cost of tender documents (Application fee) and the undertaking of the tenderer as Sl.No. vi) shall be submitted in a separate envelope marked "Cost of Tender Documents" and the undertaking and not with part-I L-1/D.
- k) In case of any discrepancy between the tender documents downloaded from the website and the master copy available in the office, the later shall prevail and will be binding of the tenderers. No claim on this account will be entertained.
- l) Eligibility Criteria:-
- Only vehicle permitted to be deployed on hire, which are already registered for commercial use as per M.V. Act.
 - Vehicles required to be roadworthy and in good condition and should be not more than 10 years old on the date of submission of Tender. However, the contract period of running the vehicle in Area is 2(two) years duration, if any of the vehicle which are roadworthy on the date of submission of Tender paper but completes its 10 years of registration in the middle, it will be discarded on the date and it has to be replaced by new one by the tenderer.
 - Vehicles are required to be covered with valid insurance certificate and should have been paid upto date road tax/permit fitness etc. as per M.V. Act - the case may be along with valid registration of ownership/Power of Attorney on behalf of owner.
 - The driver of its vehicle must possess valid commercial Driving License.

m) Evaluation:-

- In the event of L-1 Tender is having capacity constraints the Techno Commercial accepted L-1 will be counter offered to technically qualified L-2 and so on in the order of original ranking till the requirement put to tender is met.
- In case of valid offers received exceeding the requirement L-1, L-2 or L-3 and so on, order of preference will be as under:-

- Year of Manufacturing.
- Date of registration.
- Existing transport contract in BCCL.

The document can be obtained on requisite fee in writing from the P.M. (Admin), Katras Area, PO: Sjava Distt: Dhanbad on any



working day from 23.02.2009 to 27.02.2009 from 3.00 P.M. to 5.00 P.M. except Sunday/Holiday. Cost of tender document (Non-refundable) needs to be paid in cash/ Bank Draft in favour of BCCL, payable at Dhanbad to Area Finance Manager, Katras Area.

Tender shall be received in two parts in the Office of the Personnel Manager (Admin), Katras Area at 3.00 PM on 02.03.2009. The Part-I of the tender will be opened on the same day i.e. 02.03.2009 at 3.30 PM.

No tender will be accepted without requisite amount of the earnest money. Company Executives have right to reject any or all the tender without assigning any reason. Further details terms & conditions are available in the tender documents.


1. Tenderers are requested to deposit alongwith their tender with receipt of earnest money together with the cost of tender documents for the amount indicated as above in Part-I envelope.
