#### 1. ELIGIBILITY CRITERIA

- a). The intending Tenderer must have in its name as a prime contractor experience of having successfully completed similar works during last 7(seven) years ending last day of month previous to the one in which bid applications are invited should be either of the following: (1). - b). Average annual financial turnover of civil works during the last three years, ending 31<sup>st</sup>. March of the previous financial, should be at least 30 % of the estimated cost.
