### 3. Eligibility Criteria (to qualify for the award of the contract)

a) The intending tenderer must have in its name as a **Prime Contractor**, experience of having successfully executed works of similar nature (such as Transportation/Removal of coal/Overburden/Shale/Extraneous Materials/Sand etc) valuing 65% of the **Estimated Value** of the work put to tender in any year **during last 7(seven) years** ending last day of the month previous to the one in which bid applications are invited.

b) Evidence of possessing adequate working capital (**at least 20% of the Estimated Value of this work**) inclusive of access to lines of credit and availability of other financial resources to meet the requirement. Such certificates should be dated within 3 (three) months before the date of tender opening.

c) **Minimum number of equipments required for the work:-**
