- 10. Tender documents including terms and conditions of work shall be available from the office of CE(E&M) HQ during normal working hours from 20.12.2008 to 12.01.2009 against payment of the cost of tender document in cash to cashier P&P division or by Demand Draft in favour of BCCL payable at Dhanbad.
- 11. Earnest money of Rs 14,820/- shall have to be deposited alongwith offer in the form of demand draft, payment drawn in favour of Bharat Coking Coal Limited payable at Dhanbad from scheduled bank on or before 12.01.2009.

## 12. ELIGIBILITY CRITERIA

- a. Copy of purchase order for similar type of supply made in BCCL, CIL or its Subsidiaries, Public Sector Undertakings, State Govt. etc. are to be enclosed with the offer, without which tenders maybe liable for rejection.
- b. Documents for Average Annual financial turnover during the last 3 years, ending  $31^{s\dagger}$  March of the previous financial year, should be at least 30% of the estimated cost.
- c. PAN No. of the firm is to be given by the tenderer.

### 13. TERMS & CONDITIONS

a) The offers to be given only after inspecting the items to be supplied and available for display at Central Workshop East Basuria, BCCL on any working day between 9AM to 3PM.

b) Tenders shall be submitted either in English or in Hindi.

c) Any intending tenderer after obtaining tender documents having doubt as to the meaning of any part of the tender documents may submit a written request for clarification of the same. Formal addendum, if any issued by the undersigned should be final and binding by the Company and Tenderers.

d) On receipt of firm order the successful tenderer shall send their acceptance of the order within 10 days of issue of order.

e) The validity period of the tender/offer shall be 120 days from the date of opening of tender. The tenderer shall not during the said period or within the period extended by mutual consent revoke or cancel his tender or make alteration of any terms fully or partly, without consent in writing of the Company.

f) The Tender Notice shall be deemed to be part of the order.

c) The Company reserves the right to reject any or all the tenders without assigning any reason what so ever and to split up the order between two or more tenderers or except the tenders in part and not in entirety.

#### 6. RECEIPT OF TENDER:

The tenders will be received in the office of the Chief Engineer (E&M) CHP&WS upto 3-30 PM of  $14^{th}$  January,'09

#### 7. OPENING OF TENDER:

The tenders will be opened in the office of the CE (E&M)CHP&W at 4 PM on  $14^{\text{th}}$  January,'09

#### 8. DELIVERY:

The supplies in full have to be made within two and half months of receipt of Purchase Order. Part delivery will be accepted within overall delivery time.

#### 9. PAYMENT TERMS :

90% payment will be made within 30 days from the date of receipt of material and accepted after physical inspection at site. Balance 10% shall be made after successful performance on expiry of guarantee period.

#### 10. PAYING AUTHORITY: Dy.CFM(P&P), Koyla Bhawan

#### 11. GUARANTEE:

The supplied items shall be guaranteed for physical soundness/ rated performance for a period of six months from the date of supply or 1000 working hours whichever is earlier. During guarantee period, the supplier shall attend to the problem, if any, and rectify the defects /replace the defective parts free of cost.

#### 12. TRANSPORTATION:

#### 13. SECURITY DEPOSIT

In case of successful tenderer, the EMD shall be converted as Security Deposit and refunded on successful completion & acceptance of the components & on achieving the predetermined minimum guaranteed period, specified above. The Security Deposit shall be 5% of the contract value. In case the converted EMD for security deposit falls short of 5%, the balance amount shall be deposited by the tenderer within 10 days of the date of award.

#### 14 REFUND OF EMD:

The EMD will be refunded to the *unsuccessful bidders* after award of the job against this tender.

#### 15. PENALTY :

@  $\frac{1}{2}$ % of contract value per week per week of delay limited to 5% of the total order value will be imposed in case of delay in supply of items. LD will be imposed only on the supply not completed within delivery period and hence the deduction of LD will be on the part supply not completed within delivery period.


