**ELIGIBILITY CRITERIA :**

1. i) The intending tenderer must have in its name as prime supplier having experience of supplied successfully completed similar type of item during last 03(three) Years ending last day of the month previous to the one in which application is invited i.e.31-08-2009, should be either of CIL/PSU /Any Govt. Deptt.

Three similar completed works each costing not less then the amount equal to 40% of the estimated cost.

OR

Two similar completed works each costing not less then the amount equal to 50% of the estimated cost.

OR

One similar completed works each costing not less then the amount equal the 80% of the estimated cost.

1. (A) **PART -II** i.e. Price Bid should contain the following.

**Rate ( Price )** must be quoted FIRM & FOR Destination including all taxes (Sales Tax / VAT /Excise Tax applicable )

**NOTE:** The rate must be indicated both in figure and words. If there is difference between both ,the amount appearing in words shall be taken for Consideration.

2. **VALIDITY** : The offers must be valid for acceptance for a period of 06(Six) months from the date of opening Price Bid i.e. Part-II.
3. **ULTIMATE CONSIGNEE** : The materials may be consigned to the Store of BCCL (HQ.) ,Koyla Bhawan.
4. **PRICE VARIATION** : Only FIRM Price shall be quoted . No price variation will be allowed during the pendency of the contract.
5. **PAYMENT TERM** : Bill will be submitted by the tenderer after supply of materials & after acceptance of the materials by the consignee . The same will be processed for payment within 30 days.
6. **DELIVERY** : As per NIT the delivery schedule quoted in the offer should be firm & final . Delivery will be counted from the date of receipt of the order. Failure to supply of the materials in time may attract penalty.
7. **GUARNTTEE/ WARRANTY** : If the order is decided to be placed on the bidder, the bidder should confirm against the clause that in the event of any failure of performance due to defects in materials , workmanship etc. the Management shall promptly notify the supplier in writing of any claims arising under this warranty . The repairs , replacement or rectification work shall be carried out by the supplier at site at no cost to the purchase within 21 days of settlement of warranty claims. The warranty period would be 01 (one year) from the date of supply of the materials.
