Sealed tenders in two bid (Part 'A' - Technical/Commercial bid) & Part 'B' (Price bid) system, are invited from the experienced, reputed, resourceful and registered contractors for the following works at Bararee Colliery under Lodna Area. Detail of works are as under :-

Dhanbad from 29/09/2009 to 30/09/2009 (during office hours only), against application & on payment of Application Fee of Rs.100/- (Rs.One hundred only), non-refundable in the form the cash to be paid to the F.M./Cashier, Bararee Colliery, and on production of the Money Receipt.

Completed sealed tender documents (Part 'A' & Part 'B') i.e. Technical/Commercial bid (Part 'A') and Price bid (Part 'B') will be received by the Tender Committee on 03/10/2009 upto 3.00 P.M. in the tender box and Part 'A' will be opened on the same day i.e. on 03/10/2009 at 3.30 P.M.

ELIGIBLE CRITERIA :

(A) 1 (a) The intending tenderer must have in its name & style as a prime contractor experience of having successfully completed similar works during last 7(Seven) years ending last day of the month previous to the one in which bid applications are invited (i.e. eligibility criteria) should be eligible of the following :-

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

OR

Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

OR

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

The terms similar nature of works means experience in similar work/Civil Surface work to be submitted in tender (Part 'A') alongwith E.M.deposit & credential of PAN.& TIN No.(S/Tax Regtn.No.)

NOTE :

(A). 1(b) Av.annual financial turn over of civil work during the last 3(Three) years, ending 31st March of the previous financial year should be at least 30% of the estimated cost.

2. As per eligibility criteria specified under also 1(a) qualification shall be based on experience of the successfully completed works and not on experience of work in progress.
3. Completed sealed tender documents (Part 'A' & Part 'B') i.e. Technical/commercial bid (Part 'A') Price bid (Part 'B') will be received on dated 03/10/2009 upto 3.00 P.M. and Part 'A' will be opened on the same day at 3.30 P.M. in presence of the attending tenderers or their representatives. Only Part 'A' (Technical/Commercial bid) shall be opened on 03/10/2009 and Part 'B' of the eligible tenderers will be opened on competent approval. The tender without E.M. Deposit or incomplete or conditional tenders are not acceptable/liable for rejection.
4. The management of BCCL, reserves the right to reject any or all the tender without assigning any reason what-so-ever and/or to distribute the work among the eligible tenderers.
5. The Earnest money should be deposited either in Form of cash or Bank Draft drawn on any Nationalized Bank in favour of Bharat Coking Coal Limited, payable at Dhanbad, and the proof or document of E.M.D. should be submitted in Part 'A' along-with other relevant documents/credentials. No interest is payable on E.M.D.
6. The experienced as given in the eligibility criteria should be only in the name and style in which tender is submitted. The experience in the name of some other Firm/co. will not be considered for the purpose.
7. The validity period of the tender will be 120 days from the date of opening of Price bid or revised Price bid if any, which-ever is later.
8. There will no arbitration clause.
9. No material will be supplied by the dept. for the work and it will be the sole responsibility of the contractor to procure/arrange all materials, labourer etc. and tools/equipments at their own risk and cost only.
10. Credential in support of eligibility criteria should be submitted in shape of completion certificate of work done/completed and not in the shape of work order.
11. All other terms and conditions are applicable as per rules of the Co.
