- Average Annual Financial turn over of Civil works during the last three years ending 31st March of the previous financial years should be at least 30% of the estimated cost.
- Similar works means that the terderer should have experience of construction / maintenance & repairing of underground works.
- iii) Experience of having successfully completed similar work during last 7 (seven) years ending last day of the month, previous to the one in which bid application are invited should be either of the following:-
