ELIGIBILITY CRITERIA.

1. The intending tenderers must have in its name, experience of having successfully completed civil works during last 7 years ending last day of month previous to the month in which bid application are invited (i.e. eligibility period) would be either of the following:-
- a. Three similar completed civil work each costing not less than the amount equal to the 40% of the estimated cast.
OR
Two similar completed civil work costing not less than the amount equal to the 50% of the estimated cast.
OR
One similar completed civil work costing not less than the amount equal to 80% of the estimated cast.
- b. Average annual financial turn over of civil works during the three years ending 31st March the previous financial year should be at least 30% of the estimated cast.
2. Similar nature means Agency has completed the building works successfully.
- i) Previous under eligibility criteria shall also include three civil works which have been started earlier than eligibility period of under but completed successfully during the eligibility period as per N.I.T.
- ii) As per eligibility criteria specification under 1 pre qualification shall be done based on experience of successfully completed work and not on experience ~~work~~ of work in progress.
- iii) Bidders shall not be under declaration of ineligibility for corrupt and fraudulent practices issued by the Company.

3. 5% Security Money on the quoted value of the work will be deposited before execution of works agreement.
4. Tenders are to be submitted in two packed covers containing i) Technical Commercial Bid and ii) Price Bid. The Technical Commercial Bid should contain the point of eligibility criteria fixed above and also the Lowest Bid. Part-I shall be opened on 6.11.2009 at 12.30 P.M.
- The Part-II containing Price Bid will be opened by the Committee only after the department is satisfied that the eligibility criteria are fulfilled and also the Lowest Money is deposited to the acceptance of Part-I.
5. The Management of SCCL reserves the right to reject any or all the tender without assigning any reason whatsoever than to split up and distribute the work among the tenderers.
6. No tender will be issued or submitted by POSTAL MEANS.
7. The Amount Money should be deposited in form of Demand Drafts from Nationalized Bank prepared After the Mkt Date of N.I.T. in favour of SCCL account payable at Dhembad.
8. The Tender documents can be had from the office of the A.C.E.(STA), Shuli on 3.11.2009 to 4.11.2009 up to 3 P.M. in deposit of requisite cost of Tender Paper.
9. The Tender will be received on 6.11.2009 up to 12.30 Noon in the office of the A.C.E.(STA) and will be opened on the same day i.e. on 6.11.2009 at 12.30 P.M. in presence of intending tenderers or their authorized representatives.
10. Conditional tenders will not be accepted.
11. No materials will be supplied by the department for the work and will be responsibility of the contractors for procurement of the same at his own cost.
12. Issuance of Tender Documents does not mean that the parties are qualified after opening of Part-I offers, the same will be scrutinized by the Tender Committee.
13. Experience given in the eligibility criteria should be in the name and style in which tender is filled up. The experience in the name of the other firm/company will not be counted for the purposes.
14. The Validity of the tender will be 120 days from the opening of offers or revised bid if any.
15. All taxes will be borne by the Agency.
16. There will be no Arbitration Clause.
17. The Tenderers have to submit PAN NO. AND SALCS TAX REGISTRATION NO./TIN NO.
18. The Contractors has to submit the form of Affidavit which is enclosed in the Tender Paper. Without Affidavit the Tender will not be accepted.
19. The declaration of the tenderer that the tenderer has not been and banned delisted black listed by the Govt. or quasi Govt. PSU it should be submitted alongwith the Tender Documents.
20. All running A/C Bill shall be paid 95%. 21. The samples are to be supplied by the contractor on his own cost. The cost is involved in testing of materials will be borne by the contractor.
