1. Tender will be received upto 3.00PM on 16/11/2009 and the Part-I of the Tender (i.e Technical Bid) will be opened on same day at 3.30PM. The Part-II i.e. Commercial Bid be opened after the department is satisfied that criteria fixed are fulfilled and the Earnest Money is deposited.
2. The tender documents can be had from the office of ACE (EWZ) after Depositing of requisite cost of tender paper in form of cash (Non Refundable) with cashier/FM of EWZ from 12/11/2009 to 13/11/2009.
3. **ELIGIBILITY CRITERIA:**

- a) The intending tenderer must have in its name as a prime contractors experienced of having successfully completed similar works during last 7 (seven) years ending last day of Month previous to the one in which bid applications are invited (i.e. eligibility period) should be either of the following:

Three Similar completed work each costing not less than the amount equal to 40% of the estimated cost.

OR

Two Similar completed work each costing not less than amount equal to 50% of the estimated cost.

OR

One similar completed work costing not less than amount equal to 80% of the estimated Cost.

- b) Average annual financial turn over of Civil Works during the last 3 (three) years ending 31st March of the previous financial year, should be at least 30% of the estimated cost.

Note: Provision under eligibility criteria specified under Sl. No.3(a) also included those similar work which have been started earlier than eligibility period of tender but Completed during the Eligibility period as per NIT.

Similar Works means Civil Works.

4. As per eligibility Criteria specified under sl. No.3(a) pre-qualification shall be done based on experience of the successfully completed works and not on work in progress.

5. Earnest Money is to be deposited with the Associates Finance in shape of Cash or

Bank Draft drawn on any Nationalised Bank in favour of Bharat Cocking Coal Limited Payable at Dhanbad.

5. Issuance of tender Documents does not mean that the parties are considered qualified. Late and delayed tender shall not be accepted.

6. The Experience as given in the Eligibility Criteria should be in the name & style of firm which tender is filled. The Experience in some other firm/ Company will not be considered for this work/Purpose.

4. All taxes Applicable should be born by Contractors.

5. The validity of Tender will be 120 days from the date of opening of Price Bid or revised Price Bid, if any.

10. Contractors will; have get their work man registered with CMPF office & relevant CMPF rules will be applicable
11. The complete Bid documents will be available on the web-site for the purpose of Downloading & tenders submitted such downloaded bid documents shall be considered valid for participating in then tender papers.
