- a. Three Similar civil completed work each costing not less than the amount equal to 40% of the estimated cost.

Two similar completed works each costing not less than amount equal to 50% of the estimated cost.

- One similar/civil completed work, costing not less than amount equal to 80% of the estimated cost.
- Average annual financial turn over in Civil works during the last three years, ending 31<sup>st</sup> March of the previous financial year should be atleast 30% of the estimated cost.
  - Similar work means: **Surface civil works.**
