- b) The bidder must produce evidence of adequacy of a minimum working capital (either 20% of the annualized value of the work or the estimated value of the work whichever is less) for this contract. In case of obtaining credit, the certificate from scheduled bank should be produced.
- c) The bidder is required to give an undertaking in the form of an Affidavit in the prescribed format to deploy matching equipments/ tippers/ pay loaders either owned or hired. (Format placed in Annexure F of Tender Document)
