**ELIGIBILITY CRITERIA :-**

- The average Annual financial turn over during last 3 years ending 31<sup>st</sup> March of the previous year i.e. in 06-07, 07-08 & 08-09 should be at least 30 % of the estimated value.
- The intending tenderers must have in the name experience of having successfully completed some similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the followings :-
  - Three similar completed works costing not less than the amount equal to 40% of the estimated cost.

Or

- Two similar completed works each costing not less than the amount equal to 50% of the estimated value.

Or

- One similar completed work costing not less than an amount equal to 80% of the estimated cost.
- N.B. "Similar work means the nature of work as described in the name of the work should match with the work successfully completed"

**B) TERMS AND CONDITIONS :-**

- Tender will received in two envelopes. The first envelope to be marked as first envelope should contain experience certificate in his own name/firm and earnest money may be deposited with the associate finance in terms of cash or Demand Draft drawn on any Nationalize Bank in favour of Bharat Coking Coal Limited payable at Dhanbad. The intending tenderer must submit permanent income tax account number (PAN).
- In the 2<sup>nd</sup> envelope (to be marked as 2<sup>nd</sup> envelope). The tender paper with rate should be submitted. Tender document can be had from the office of the undersigned on written request on any working day from 1/12/09 to 2/12/09 during office hour on payment of requisite cost as indicated above to be deposited in cash with associate finance at Sijua Area.
